ACTONS FARM

Held of the Manor of Pebsham but is liable to a Heriot on death to the Manor of Bexhill

PROPERTY DETAILS (NGR TQ 7501 1025)

This farm is still in operation today (1999) but it's history cannot be ascertained prior to 1839 as yet. Actons fell within the Manor of Pebsham and no records of this Manor are available at the East Sussex Record Office. Some old Court Books of the Pebsham Manor are kept at the British Library under the reference Court Book 1492-1625 ADD MS 33-173, ffl-144 and Court Book 1561-1639 ADD MS 33,176. No plans have been found before the Tithe Map of 1839.

A detached bungalow, referred to originally as The Cottage, was built in 1931 by Mr A.J.Collins (plan 5643 at the Planning Office in Bexhill Town Hall). There are previous older footings beneath. There was a change of use from agricultural to nonagricultural use for this cottage by Mr Sydney Message in 1965. This is now being owned separately from the farm.

A new cow house was built in 1932 by the executors of the late Mr Collins.
