FREEZELAND FARM

Holden of the Manors Of Bexhill and Buckholt

PROPERTY DETAILS (NGR TQ 7270 1030)

The old farmhouse has been demolished, it was situated hard on the land called Freezeland Lane. The Oast House has been converted and some of the other buildings survive. The early history has not yet been investigated.

At a sale of the property on 11 July 1848 it is described thus: It consisted of Farmhouse, Barns Oasthouse, Stable and other farm buildings being part freehold and part copyhold. 36 acres 3 roods 18 perches of good land. A portion of the land comprising 13 acres and 33 perches is a copyhold inheritance holden of the Manor of Buckholt and is subject to an annual Quit Rent of 1s 8d and to a fine or heriot certain of 3s 4d on death or alienation payable to the Lord or Lady of the said Manor. A further portion 6 acres 3 roods and 20 perches is also copyhold inheritance holden of the Manor of Bexhill subject to a heriot of the best live beast on death or alienation and to an annual Quit Rent of 8d payable to the Lord or Lady of the Manor of Bexhill. Freezeland and Banks were farmed together in the middle nineteenth century and they were valued on 21 July 1883, the report being sent to Sir Anchitel Ashburnham and reads thus:

We went over this property on the 19th inst and fined it comprises of a farmhouse, cottage, oasthouse and several enclosures of arable, pasture and woodland and one piece of market garden ground, the whole containing 66 acres 3 roods 15 perches. Part is copyhold but most freehold and some portions of that are liable to Manorial Customs, heriots, fines and quit rents. Our Valuation of this property is £3,540 sign J.W.C. Vidler Son and Clements. (2)
